AMENDEMENT

“13 Amount levied and collected shall be kept in Government Account:

Municipal Corporations, Municipalities and Urban Development
Authorities in the state, under these Rules, shall be credited to the
Government Account to the head of account '0217 Urban Development
60 other Urban Development Schemes, M.H. 800 other receipts SH (05)
Fees collected towards penalization Charges for penalizing the
unauthorized constructions and un-approved Layouts' (to be opened).
The same shall be released for developmental works in respective
Municipal Corporations / Municipalities / Urban Development Authorities
as per the priorities of the respective Urban Local Bodies / Urban
Development Authorities based on the policies of the Government.”
