**ORDER:**

In the G.O. first, as amended in the G.O. 2<sup>nd</sup>, 4<sup>th</sup> and 5<sup>th</sup> read above, the time “on or before 31-05-2008” was stipulated for filing applications under Regulation and penalization of existing unauthorizedly constructed buildings, and buildings constructed in deviation of sanctioned Plan Rules 2007. However due to pendency of W.P. No. 1069 of 2008, before the Hon’ble High court, challenging the said rules issued in the G. Os read above, and also in view of the fact that in the reference third read above, the Revenue (Assn.POT) Department had given time upto 30-06-2008, for submission of applications for regularization of encroachments by way of dwelling houses, the Government have decided to extend the time for submission of applications upto 30-06-2008.

Accordingly, the Government, in exercise of the powers conferred under Section 455 AA of the Hyderabad Municipal Corporation Act, 1955, Section 218 (A) of the A.P. Municipalities Act, 1965, Section 46(A) of the AP Urban Areas (Development) act, 1975, hereby issue the following amendment to the Rules issued in the G.O 1<sup>st</sup> as amended in G.Os 2<sup>nd</sup>, 4<sup>th</sup> and 5<sup>th</sup> read above.

**AMENDMENT**

In Rule 3 of the said rules for the words “on or before 31-05-2008” the following words shall be substituted, namely:

**“On or before 30-06-2008”**
